

is part of a collaborative effort to
ensure the immediate and
comprehensive assessment of
children and youth under the
jurisdiction of Child Welfare
Services for the reunification of the
family unit in SPA 6, specifically in
South Los Angeles.

The MAT program provides services to families and children (0 -21) who are under the jurisdiction of Child Welfare Services by proving an in-depth assessment of family strengths and psycho-social needs, resulting in an intensive care plan including linkages to resources that will aid the family in working towards achieving family reunification. Clients may also receive ongoing mental health services dependent on staff availability and need of client.

The MAT is a court-ordered assessment process that is a collaboration between the Department of Mental Health (DMH), the Department of Children and Family Services (DCFS) and community providers. The MAT concept is family centered and strength based. When a child is detained, he/she is eligible to receive a MAT assessment. The value of this assessment is that it presents a comprehensive understanding of the complicated issues that children and families face when they enter the foster care system. Therefore SHIELDS can more effectively





successfully provided linkages for children and adolescents to SHIELDS HUB Outpatient Mental Health Clinic as well as SHIELDS Revelation program. We have also provided linkages to parents/caregivers to SHIELDS programs that provide substance abuse treatment

including the Ark program as well as SHIELDS Achieving Change Together (ACT) program.

The MAT model is committed to providing services in the areas of mental health, physical health, developmental milestones, hearing/language development, education and vocational needs in a manner that is most conducive to achieving permanency and optimal stability for the child in the least restrictive setting. Thus services are intended to build on the strengths of the child and family. Our assessors have collaborated with Service Planning Areas (SPA) 3 and 7 as well as Orange County and Riverside County in order to complete assessments and provide linkages to clients and their families. Our cases are only closed after all recommendations and court requests are met.



Program Highlights

- In the first 9 months of 2010, the SHIELDS MAT program assessed over 100 children.
- Cases that SHIELDS assess early on, with concrete interventions, move through the system faster, therefore reducing the time to achieve permanency.
- SHIELDS MAT Assessors have being able to provide continuous mental health (individual and family psychotherapy) services to the child(ren)/family in order to facilitate reunification.
- Early assessment of appropriate placement options decreases the number of placement disruptions and increases the level of safety while in out-of-home care.
